Coverage Rationale

Full mouth Debridement is indicated when, due to the amount of calculus, plaque, and debris, a comprehensive examination is not possible.

Definitions

Debridement: Removal of subgingival and/or supragingival plaque and calculus which obstructs the ability to perform an evaluation.

Description of Services

Full mouth Debridement is a dental procedure that is indicated when the amount of deposits present is extensive and prevents the dentist from being able to conduct a complete examination. The need for this procedure is typically seen in patients who have not received dental care in many years, or have difficulty performing daily oral care. It is not considered therapeutic or preventive, and must be followed by definitive procedures such as prophylaxis or scaling and root planing.

Pursuant to CA AB2585: While not common in dentistry, nonpharmacological pain management strategies should be encouraged if appropriate.
