## Application

This Medical Benefit Drug Policy only applies to the state of Ohio. Any requests for services that are stated as unproven or services for which there is a coverage or quantity limit will be evaluated for medical necessity using Ohio Administrative Code 5160-1-01.

## Coverage Rationale

Refer to the Medical Benefit Drug Policy titled [Oncology Medication Clinical Coverage \(for Ohio Only\)](#) for updated information based upon the National Comprehensive Cancer Network (NCCN) Drugs & Biologics Compendium® (NCCN Compendium®) for oncology indications.

This policy refers only to Actemra (tocilizumab) injection for intravenous infusion. Actemra (tocilizumab) for self-administered subcutaneous injection is obtained under the pharmacy benefit.

**Actemra® (Tocilizumab) is proven and medically necessary for the treatment of certain conditions outlined within the InterQual® criteria.** For medical necessity clinical coverage criteria for non-oncology indications, refer to the current release of the InterQual® guideline for Actemra: CP: Specialty Rx Non-Oncology, Tocilizumab (Actemra).
